Golf Outing Terms & Conditions:

Kern River GC recommends at least 100 players to consider an 18 hole shotgun start. Less than 100 players may start using a modified shotgun start. (Modified Shotgun: a shotgun start in which a portion of the 18 holes is occupied in order for the club to open the remainder of the facility for public play).

A total of 120 players guarantees an 18 hole shotgun start.

Payment

In order to reserve the date and time indicated above, I understand and by my signature on this Contract, hereby agree to the following terms:

~This golf event contract must be signed and returned to formally secure the requested outing date.

- The FINAL GUARANTEE for all golfers, including all outing volunteers, is due 10 days prior to the event date. Groups arriving with fewer than the guaranteed number of golfers will be charged for 50% of the golfers that did not show.
- The FINAL BALANCE must be paid in full no later than end of day on the event date. This amount can be paid with cash, corporate check or credit card. Please make checks payable to Kern River Golf Course.
- PLAYER COUNT AND LIST: A "Player List" or a pairing list must be faxed or emailed to the Pro Shop Manager no later than three days prior to your golf outing date. Fax to 661-872-4965 or Email: nick@kernrivergolf.com or jacque@kernrivergolf.com)

We asked for your full cooperation so that our staff can prepare for your event.

FOOD AND BEVERAGE

All food and beverages must be purchased from Kern River Golf Course. Any outside catering request must be approved by our staff in advance. No personal coolers or containers are allowed. No alcoholic beverages are permitted to be brought on the course.

SIGNAGE

Any signage utilized by the tournament must be claimed by event coordinator and removed from the property at the conclusion of the event. After 72 hours, all signage left beyond that time will be discarded.

CANCELLATION POLICY

In the event of a cancellation, please provide Kern River Golf Course with 14 days advance notice of this cancellation. Failing to do so will result in a \$300 cancellation fee.

INDEMNIFICATION

Client hereby jointly and severally agrees to indemnify, defend and hold Kern River Golf Course, Inc. harmless from all claims, suits, actions at law, judgments, liabilities, losses and damages (including attorney's fees) arising from the use of Kern River Golf Course property, however caused, including without limitation, any injury or damages resulting from negligent, careless, improper or unlawful conduct.

DAMAGES

We agree to exercise extreme caution when operating equipment (specifically but not limited to golf carts) and utilizing the golf course property. We agree to only 2 riders and bags per cart. In the event that we caused damage to the property and/or equipment used by our participants, we agree to pay in full for any damages.

CONDUCT

Proper conduct is expected by outing participants while on the golf course. Player should adhere to golf cart path rules, replace divots, repair ball marks and rake sand traps. Unruly behavior, foul language, golf cart abuse, club throwing and hitting into groups will not be tolerated. Any player that chooses not to follow these rules will be asked to leave the premises.
